The librarians evaluated student knowledge regarding the organization of the library’s collection as well as student ability to use the library’s classification system to retrieve information resources within the library. In addition, the librarians evaluated student confidence levels regarding individual ability to locate print resources in the library, and more specifically to use the library’s online catalog to search for items in the library collection and the ability to use an item’s call number to locate an item on the library shelves. Student knowledge and abilities as well as student confidence levels were assessed prior to and following a librarian led instruction session through the use of a pre and post-test assessment method.

- Recognize that knowledge can be organized influencing the way information is accessed.

Students attending librarian led instruction sessions during the Fall 2016 and Spring 2017 semesters were invited to take part in the assessment.

1c. What was the sample size of the group assessed/the number of possible students?

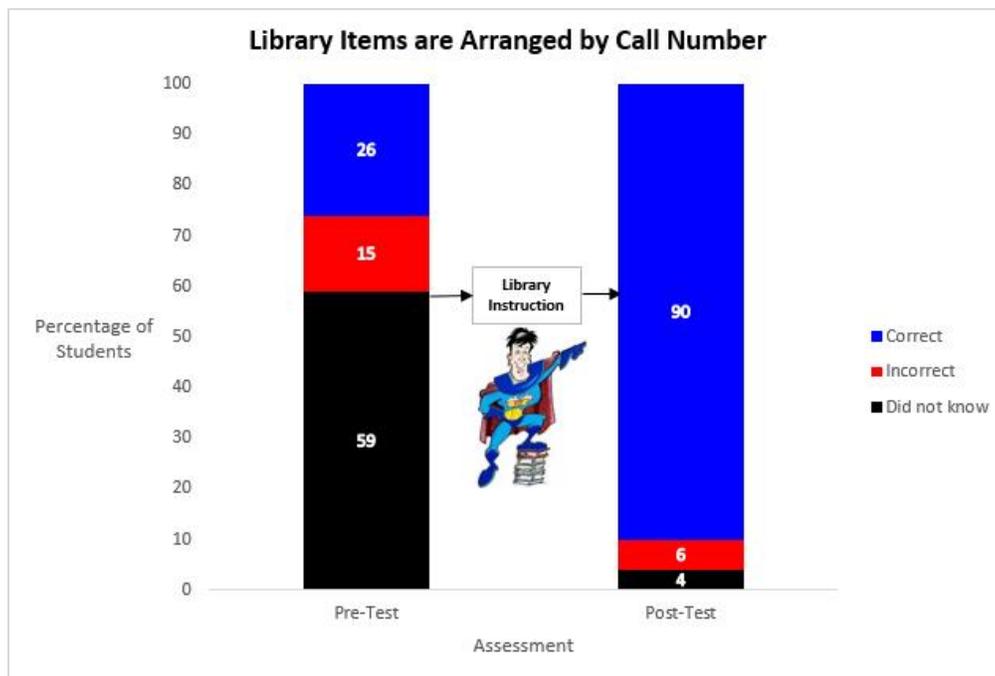
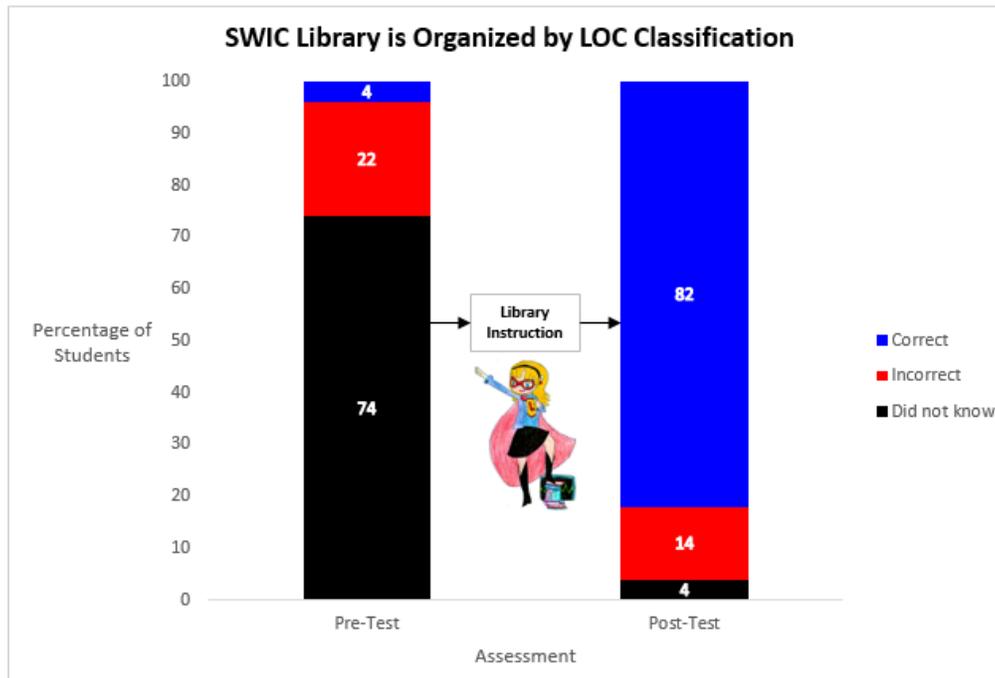
Librarian led instruction was provided to 1,548 students during the Fall 2016 semester and 1,422 students during the Spring 2017 semester, averaging 1,485 students per semester. 110 students took the pre-test equating to 7% of the possible population and 83 students took the post-test equating to 6% of the possible population.

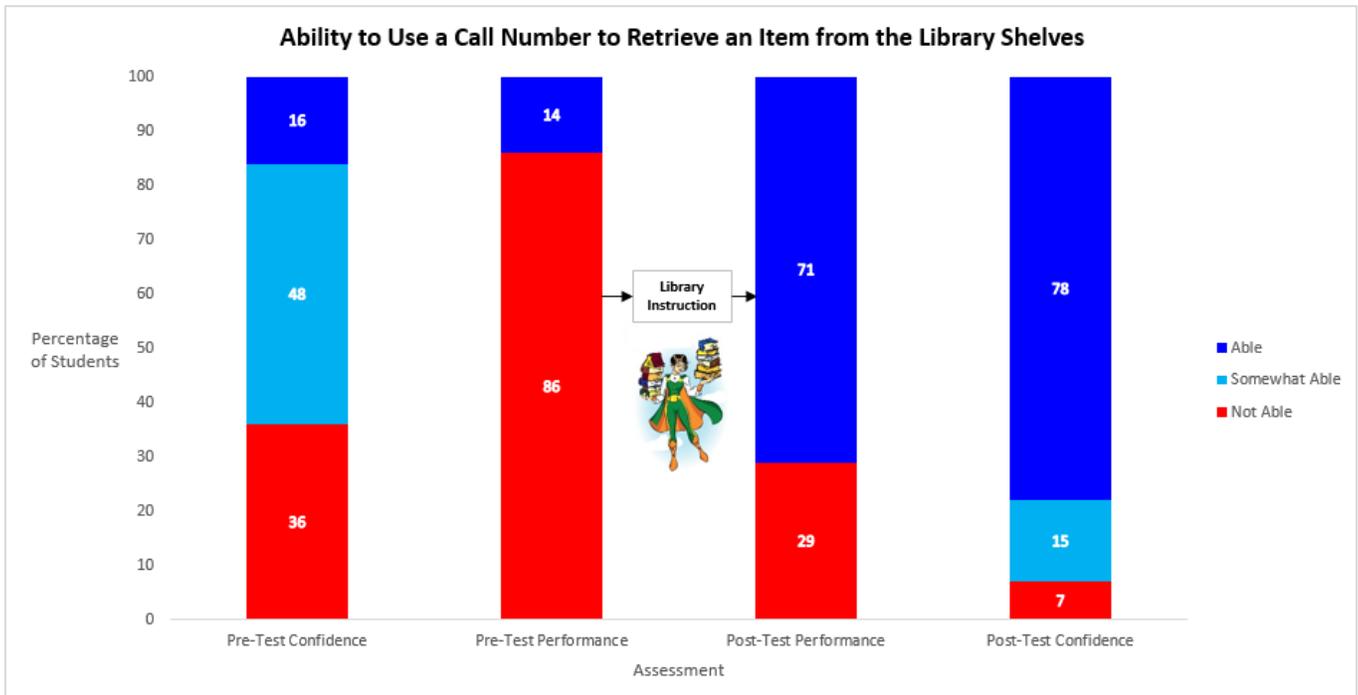
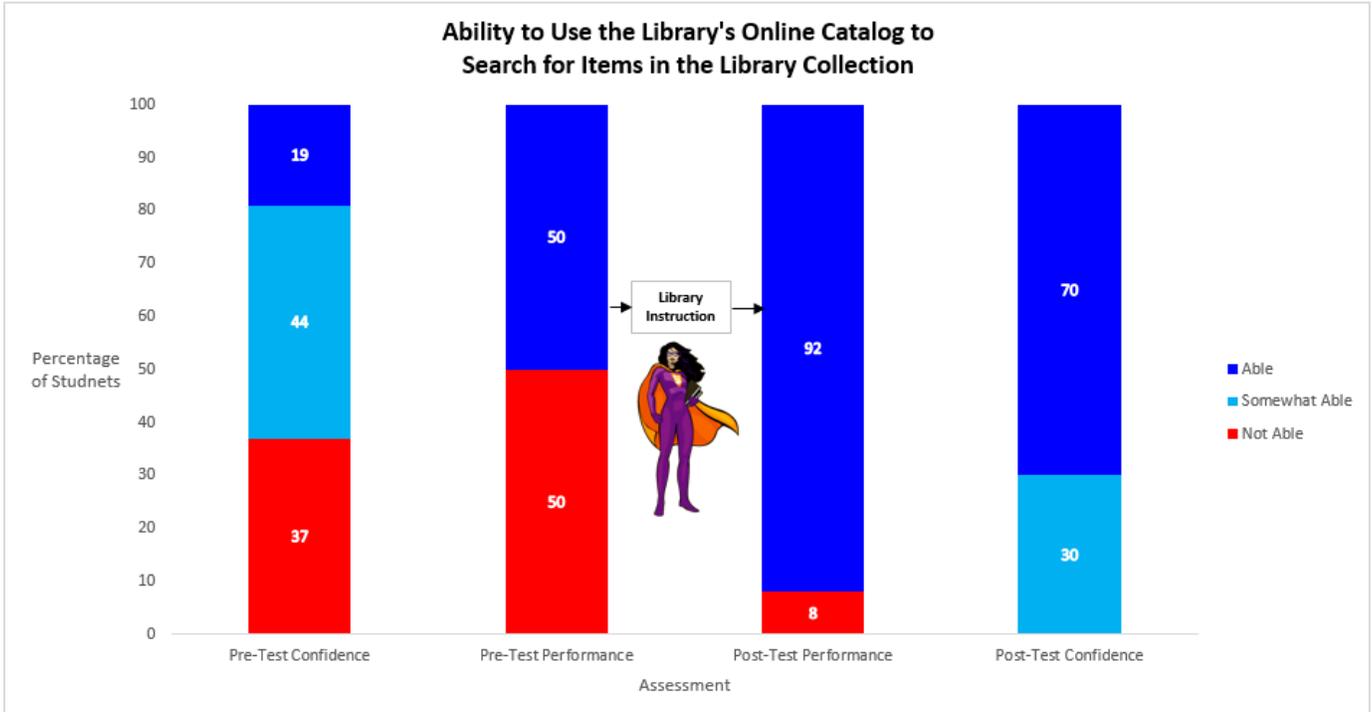
A pre-test and post-test was administered by the librarian to students before and after a library instruction session (see attached).

3a. What was the cut off point (benchmark) using this tool which would indicate satisfactory performance on the goal/objective or core competency skill assessed?

As a result of participating in a librarian led instruction session, the librarians expect 7 out of 10 students, or at least 70% of students assessed, to know the organization and arrangement of the library collection and have the ability to search for and retrieve library items from the library shelves. In addition, at least 70% of students assessed should express confidence in their ability to search for and retrieve items on their own when future informational needs arise.

4a. What is the analysis/interpretation of these results/trend results?

When evaluating student knowledge prior to the library instruction session, it was determined from the pre-test that only 4% of students assessed knew that the library's collection is arranged by the Library of Congress classification system and just 26% knew that library items are arranged on the shelves by call number. Following a librarian led instruction session these figures improved significantly to 82% and 90% respectively.

When evaluating student ability prior to the library instruction session, it was determined from the pre-test that only 50% of students assessed showed that they were capable of using the library's online catalog to search for items in the library's collection. In addition, just 14% of the students assessed could successfully use an item's call number to retrieve an item from the library shelves. Following a librarian led instruction session these figures improved significantly to 92% and 71% respectively.

When evaluating student confidence levels prior to the library instruction session, pre-test results show that only 19% of students assessed indicated they felt capable of using the library's online catalog to search for items in the library's collection and 44% indicated they felt somewhat capable. It was also determined that 16% of students indicated they felt capable of using an item's call number to retrieve an item from the library shelves and 48% indicated they felt somewhat able to do so. Following a librarian led instruction session, these figures improved significantly. Post-test results show that 70% of students indicated that they felt capable of using the library's online catalog to search for items in the library collection and 30% felt they were somewhat capable. Furthermore, 78% of students indicated they felt capable of using an item's call number to retrieve an item from the library shelves and 15% felt somewhat capable.

4b. Did the groups meet the benchmark?

Post-test results showed that students exceeded the benchmark in all areas assessed. A comparison of pre and post-test data show that librarian led instruction significantly improves student knowledge, ability and confidence levels regarding the organization of the library's collection and the ability to use the library's classification system to retrieve information resources within the library.

The librarians evaluated student knowledge, ability and confidence levels regarding the organization of the library's collection and the ability to use the library's classification system to retrieve information resources within the library and more specifically to use the library's online catalog to search for items in the library collection and the ability to use an item's call number to locate an item on the library shelves. Student knowledge and abilities as well as student confidence levels were assessed prior to and following a librarian led instruction session through the use of a pre and post-test assessment method.

When evaluating student knowledge prior to the library instruction session, it was determined from the pre-test that only 4% of students assessed knew that the library's collection is arranged by the Library of Congress classification system and just 26% knew that library items are arranged on the shelves by call number. Following a librarian led instruction session these figures improved significantly to 82% and 90% respectively.

When evaluating student ability prior to the library instruction session, it was determined from the pre-test that only 50% of students assessed showed that they were capable of using the library's online catalog to search for items in the library's collection. When evaluating student confidence levels prior to the library instruction session, pre-test results show that only 19% of students assessed indicated they felt capable of using the library's online catalog to search for items in the library's collection and 44% indicated they felt somewhat capable. It was also determined that 16% of students indicated they felt capable of using an item's call number to retrieve an item from the library shelves and 48% indicated they felt somewhat able to do so. Following a librarian led instruction session, these figures improved significantly. Post-test results show that 70% of students indicated that they felt capable of using the library's online catalog to search for items in the library collection and 30% felt they were somewhat capable. Furthermore, 78% of students indicated they felt capable of using an item's call number to retrieve an item from the library shelves and 15% felt somewhat capable.

The results show that librarian led instruction significantly improves student knowledge, ability and confidence levels regarding the organization of the library's collection and the ability to use the library's classification system to retrieve information resources within the library and more specifically to use the library's online catalog to search for items in the library collection and the ability to use an item's call number to locate an item on the library shelves. Following library instruction, student knowledge, ability and confidence levels exceeded the benchmark.

The lowest post-test result of 71%, while it exceeded the benchmark, was with the student's ability to retrieve an item from the library shelves. To improve, the Library plans to place directional signage at the end of each library range to guide students across the library aisle to the next range in the collection.
