

## SPECIAL MEETING BOARD OF TRUSTEES SOUTHWESTERN ILLINOIS COLLEGE DISTRICT NO. 522

#### **CALL TO ORDER**

A special meeting of the Board of Trustees of Southwestern Illinois College, District No. 522, was held Wednesday, April 26, 2023 in the Marsh Conference Room at the Belleville Campus, 2500 Carlyle Avenue, Belleville, Illinois. Chairman Nick Raftopoulos called the special meeting to order at 5:30 p.m. and stated the purposes of the special meeting were to certify the April 4, 2023 consolidated election results as submitted by the county clerks for each county serving Community College District #522 and to reorganize the Board of Trustees.

#### **PUBLIC COMMENTS**

President Mance thanked the outgoing trustees for their years of service on the Board and provided the following brief highlights during the terms of office of two of the longest continuously serving SWIC trustees: Richard Roehrkasse 1991 (32 years and longest serving trustee) and Robert Morton 2001 (22 years):

• Belleville Area College celebrates 50<sup>th</sup> anniversary.

#### 1999

• Belleville Area College begins classes at the East St. Louis Community College Center.

## **2000**

- Belleville Area College name changed to Southwestern Illinois College.
- Red Bud Campus expansion.
- Belleville Campus Information Sciences Building completed and opened.

#### **2001**

- MetroLink station opened at the Belleville Campus.
- The college became an AQIP institution and was a pilot for the Commission's Vital Focus program in 2002. As part of this program SWIC worked with Higher Learning Commission (HLC) staff for three days to design and conduct a program of surveys, workshops, and large-group processes that were designed to identify strengths, opportunities, priorities, and Action Projects.
- The William and Florence Schmidt Art Center opened on the Belleville Campus.

• Belleville - Fire Science training tower authorized.

#### 2004

• Belleville Campus - Liberal Arts Phase I building construction approved.

#### **2006**

- Governor Blagojevich joined college officials to rename the Granite City Campus to the Southwestern Illinois College Sam Wolf Granite City Campus in honor of the former state representative who had been a college Trustee since 1995-2012.
- Belleville Campus Liberal Arts Phase I building opens.
- Belleville Area College celebrates 60<sup>th</sup> anniversary.

#### <u>2007</u>

- Sam Wolf Granite City Campus expansion building improvements and added more classrooms.
- Fire and Rescue Training Center completed in Belleville.

#### 2008

• Belleville Campus Liberal Arts Phase I building opened.

#### 2011

• Approval for construction of an environmentally-friendly, 72,000 square-foot expansion of the Liberal Arts Phase II building.

## **2013**

- AQIP System Portfolio accreditation submitted and approved by the HLC.
- Liberal Arts Phase II building opens.

#### 2015

• Belleville Campus Information Sciences building renovation.

• Belleville Area College celebrates 70<sup>th</sup> anniversary.

## July 2018 - Present

- Introduced more than twenty-five new degrees and/or certificates for ICCB and HLC approvals to capture new students and to increase enrollment.
- HLC announced the phasing out of the AQIP Pathway. The College submitted a 2019
  Systems Portfolio to determine the level of monitoring and pathway for accreditation.
  The Systems Portfolio was approved by the HLC and as of September 2019, the
  institution was placed on the Open Pathway (desired pathway).
- Belleville Campus Construction of a Manufacturing Training Academy building.
